Taking Control

Take Control of Your Healthcare

Health Savings Accounts offer a tremendous opportunity for you to take control of your healthcare. Created as part of the Medicare Bill passed in December of 2003, the combination of a High Deductible Health Plan (HDHP) and an HSA offers you a tax advantaged way of lowering the premiums you pay for health insurance coverage while investing all or a portion of the savings in a tax advantaged account.

You control the specifics of your healthcare coverage and your healthcare spending. Because it's your money, you and your doctor are your healthcare decision makers.

It's Your Money!

The money deposited in your HSA, whether it is deposited by you or your employer under a qualified group HDHP plan, is yours. The money can be used to pay for current qualified medical expenses or it can be saved for future medical expenses. The dollars in your HSA are managed by you and are eligible to roll over from year to year.

All contributions to your HSA are either deductible to you under an individual plan or not includable in your taxable wages under a group plan. HSA distributions are tax free if used for qualified medical expenses.

Getting Started

The first step towards taking control of your healthcare is to make sure you have a qualified HDHP in place. Most insurance companies are offering a qualified product.

With a qualified HDHP in place, you are eligible to open your Cattle National Bank & Trust Company *No Bull* HSA account. To apply, stop in or download the plan documents from our website, www.cattlebank.com. Because the application and funding can be completed by mail, you are eligible no matter where you live. When you have completed the application, you can return it to us along with a check for the \$20 enrollment fee and your initial deposit of \$25 or more.

Once accepted, your account will be opened. You can expect to receive your personalized HSA checks in about a week and your debit card in about three weeks. You can contribute to your HSA on your schedule and at your convenience.

Your HSA account checks and debit card work just like a regular bank account. You can use these tools to pay for qualified medical expenses directly or to reimburse yourself for medical expenses paid out of your regular account. Be sure to keep your receipts for qualified medical expenses on file in order to substantiate your distributions for IRS purposes.

Before You Begin

We strongly encourage you to consult your tax advisor regarding the tax benefits of an HSA for your particular situation. Contribution eligibility and limitations are subject to IRS rules. More information is available at www.treas.gov or www.irs.gov. You are responsible for assuring that distributions from your HSA are made in accordance with IRS rules.
